### Corrections to January Article Unpaid Assessments Can Lead to Legal Actions

- There are **no** alternative payment plans for assessments. Assessments can be paid a year in advance or they can be paid quarterly. Cindy Borquez does **not** work out alternative plans on a case-by-case basis with delinquent homeowners.
- According to state law (ARS 33-1807), as soon as an assessment is overdue a lien is placed on the property. We do not need wait for two unpaid assessments and we do not need to go to court to place a lien.

# Improvements Made to the Walnut Entrances & the Riverhaven West Easements

To improve neighborhood security, new wrought iron fencing was installed at the Walnut entrances. A locked truck gate and a self-closing pedestrian gate with a "no trespassing" sign are now in place. (Residents can still easily enter and leave Riverhaven using this gate.) The chain link fencing to the west of the Walnut entrances has been repaired or replaced as needed. The fence line has been cleaned up. The common areas adjacent to the pedestrian entrance have been cleaned out and trees have been pruned up or cut down to improve visibility. The southern and western easements of Riverhaven West have been cleaned to eliminate hiding spots for criminals as well as to reduce the risk of fire.
