### **No Soliciting Signs Are In Place**

Residents can now inform any salesman that comes to their door to leave Riverhaven; we are now a "no solicitation" posted community. Residents can also notify the many companies who leave their flyers at our homes. If you are uncomfortable with this, you can notify Cindy Borquez with the name of the company and a phone number to call so that she can follow up. Also, new signs with the correct spelling of "soliciting" will be installed at no cost to the HOA. (Thanks Melanie!) If you want to stop telemarketing calls register with National Do Not Call Directory at https://www.donotcall.gov/. Once registered, you may file a complaint if you received an unwanted call after your number has been on the National Registry for 31 days. You may also file a complaint if you received a call that used a recorded message instead of a live person (whether or not your number was on the Registry).

# Wash Clean Up On Saturday February 13th



Our yearly trash pickup will be Saturday 2/13/10 from 8:00am – 11:00am. The focus will be the Christopher Wash that runs from east to west from Columbus and turns north to south behind Wading Pond & River Rapids. However, if there is another part of Riverhaven where you want to pick up that's fine with us. If you want to help tidy up the neighborhood but don't want to pick up trash, there is always a side walk that needs to be swept! Trash bags will be handed out on the walking path near Paradise Falls. When the trash bags are full and ready for pickup leave them near the drainage ditches on River Rapids. Be sure to wear closed toed shoes and long pants while picking up the trash. We're looking for a

## **Board Highlights from January**

- Final figures for bad debit (unpaid & uncollectable assessments) in 2009 were significantly below predictions. If this year's (2010) predictions on bad debit are also high, we will consider budgeting for lower levels of bad debit in the 2011 budget.
- Bids will be send out for 1) tree trimming & cleanup of the easement between the River Point Apartments and Riverhaven, 2) to remove HOA tree limbs threatening the north wall of the apartments and 3) to install a gate & fence at the southern end of the easement with the apartments to prevent access to the area.
- The chair of the Architecture Committee will work on revising the design review form to make the process more understandable and quicker for residents.
