

News from the River's Edge June 2008 Update

DRAFT Board Goals & Objectives for 2008/09 to be finalized at the June 11th Board meeting.

1. Keep Riverhaven a desirable location to buy a home and live.

- Keep Common Areas clean and attractive.
- If funds are available, continue to improve landscaping in the Common Areas.
- Work with occupants to keep individual homes weed free, maintained and landscaped as per the Design Guidelines.
- Develop a method to inform renters of the CC&Rs, Design Guidelines and other relevant policies and procedures of which they will need to be aware while living in Riverhaven, an HOA controlled community.
- If necessary, Board members will volunteer keep the yards of any abandoned or foreclosed homes in Riverhaven in compliance with the *CC&Rs* and *Design Guidelines*.

2. Improve neighborhood safety.

- Clean and maintain all washes to keep water from backing-up during storms.
- Remove as much flammable debris (dead plant material, trash, etc.) as possible from all washes to make it harder for fires to start and spread.
- Participate in National Night Out (America's Night Out Against Crime) on Tuesday August 5, 2008.

- Develop a method to require landlords with rental properties in Riverhaven to use the "Crime Free Lease Addendum, Arizona Version" with their leases. [http://www.crime-free-association.org/lease_addendums_az_english.htm]
- Install traffic circles on Riverhaven & Deer Dancer and Riverhaven & Paradise Falls.
- Investigate putting a traffic circle on Paradise Falls & Pebble Rapids.
- Locate, paint a bright color and clearly mark on a map all of the gas monitoring wells for which the Association is responsible.

3. Improve communication.

- Devise a way to make important notices easily visible on the Riverhaven website.
- Rewrite the *Design Guideline* restatement on trash cans to make it clear and easily understandable.
- Clearly mark the property line on the north side of Riverhaven West.
 - Use to communicate to our contract landscapers their area of responsibility in maintaining Riverhaven's Common Areas
 - To use for bids in future projects.
 - o Keep neighborhood clean-up projects within our property boundaries.

Reporting Violations to Cindy Borquez

- Cindy Borquez, our community manager, cannot accept anonymous problem reports. Both Cindy and the Board keep complaints confidential, so please include complete contact information with your report.
- In the past, violation notices resulting from problem reports accompanied by photos were sent under Cindy Borquez's name. She has been informed by her superiors that this cannot continue.
 - If the resident who sent in photos with their problem report *approves having their name* on a violation notice then, if justified, a *notice will be sent*. This applies to all future problem reports.
 - Without the name attached a violation notice can only be sent if Cindy Borquez sees the problem with her own eyes. We realize that this could cause problems with parking complaints.

National Night Out: America's Night Out Against Crime

Our Safety Committee Chair, Maureen Morrell, is planning for Riverhaven to participate in this year's **National Night Out** on **Tuesday August 5th.** National Night Out was introduced in 1984 and it is an effort to heighten awareness and strengthen participation in local anticrime efforts.
