

# News from the River's Edge September 2008 Update

#### The Big Storm of August '08: Trees Down, Tiles Up

Many residents lost trees in the terrible storm we had the night of 8/13/08. The *missing trees must be replaced*. The restatement of the guidelines for front yard landscaping and the "Drought Tolerant & Low Water Use Plant Use Guide" (the approved plant list) are both on the Riverhaven website (<a href="www.riverhaven.us/docs.htm">www.riverhaven.us/docs.htm</a>). If you want to use a plant to replace a downed tree that isn't on the approved list or if you don't want to replace the tree you will need to submit an Architectural Design Review form with your request to Cadden for Board approval. You can find the ARC form on the website (<a href="www.riverhaven.us/docs.htm">www.riverhaven.us/docs.htm</a>); click Architectural Review Committee Form and print.

In addition many, many houses had tile damage to their roofs. *Damaged tiles are a safety hazard; they must replaced and the roof repaired.* If you haven't yet repaired your roof please do so ASAP. #### **Resident Information Sheet**

There are times when it is necessary, like after our violent storm last month, for Cadden to have emergency contact information for a house in Riverhaven. ## Re-Write of Trash and Recycle Can (Sanitation) Guideline

Several years ago when the Board found out that many homes in Riverhaven do not have gates wide enough to allow trash cans to be put in the backyards the original guideline was rewritten.
